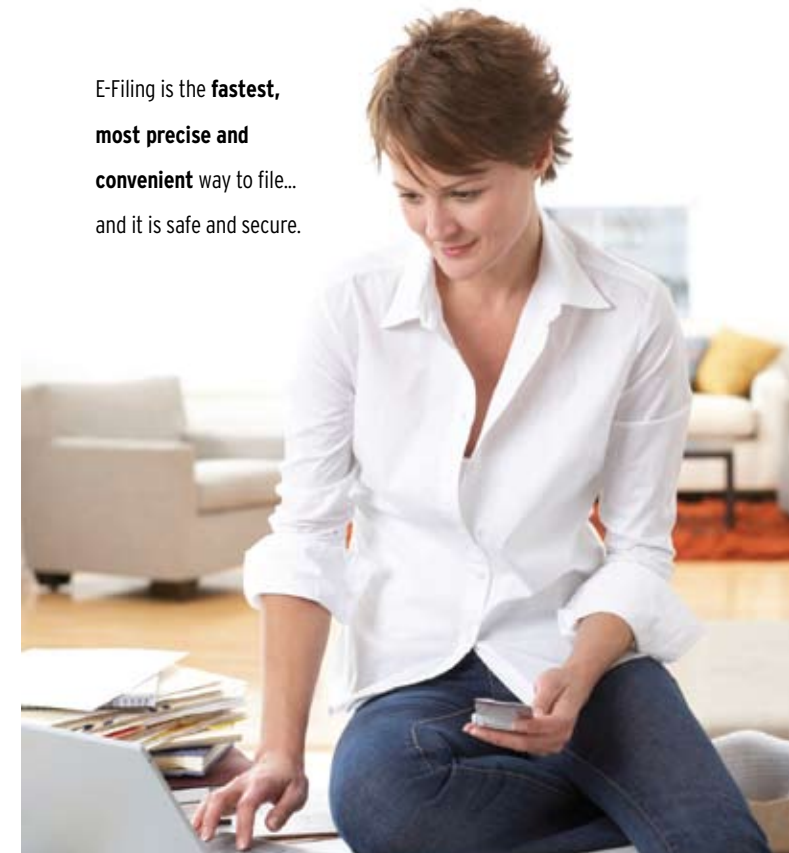

What is E-Filing?

E-Filing is a **precise, convenient and speedy** way to file your tax return electronically, one that more and more Louisiana taxpayers are using. Tax information is entered into tax preparation software that automatically encrypts and secures each return. You or your tax preparer can save your return electronically or print paper copies for your records.

E-file allows you to take advantage of more electronic options.

If you are due a refund, you can have the refund deposited directly into your bank account.

If you must pay additional tax, you can authorize the Department of Revenue to electronically debit your bank account on the date of your choice.

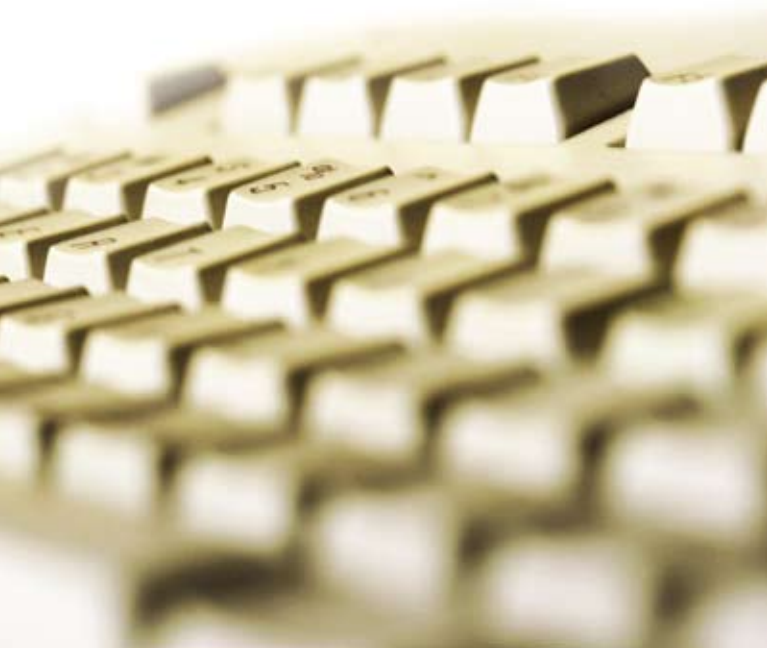
E-File with **DIRECT DEPOSIT** is the fastest way to get your tax refund.

Almost 70 percent of refunds in 2007 were issued within 14 days of electronic filing.

E-Filing is a **safe, secure, precise, convenient and speedy** way to file your Louisiana income tax return.

You can E-File using most tax preparation software or your tax preparer can E-File for you.

Information about your refund is available around-the-clock.

You can obtain information about the status of your refund at www.revenue.louisiana.gov.

You can sign your return electronically.

All E-Filed returns are signed with a personal identification number (PIN). Your software or paid tax preparer will guide you through this easy process.
